## Please Read Carefully

- **2018** Registration Fee is **\$160.00** per vehicle. This registration fee entitles that vehicle to participate in transporting delegates to and from their destination. Upon registration, a photocopy of the driver valid driver's license and a copy of an insurance card verifying the vehicle is insured must be attached. **Registration fee is non-refundable.**
  - Each primary driver will be allowed 2 additional drivers per vehicle. The registration fee for each additional driver is \$50 plus a \$10 Badge fee. Any vehicle exceeding 2 additional drivers will be assessed the \$160.00 registration fee.
  - Additional drivers of the same vehicle must register their driving information and abide by all the rules of this contract, as well as fill out the Transportation Sign-up Form.
  - Before the convention, the driver will be issued their GMWA Badges and required Emblems/Placards to be placed on their person and within the registered vehicle, and must be visible at all times. At no time during the participation of transporting Delegates, shall these items be removed. At no time can these items be placed with another individual, nor inside another vehicle that has not been registered.
  - If at any time a driver is reported for poor conduct, mishandling of luggage or not following the Rules and Regulations Guidelines, the GMWA Transportation Committee has the authority to remove the decal and dismiss the driver.
  - The driver is responsible for their own fueling, toll fees if any, and any traffic violations incurred during their participation.
  - Let it be known the Gospel Music Workshop of America, Inc. incurs no liability of any kind in your participation in this event.
  - The driver is responsible and can assist with the handling of luggage for the individuals they transport.
  - The driver is responsible for following the pricing guidelines set forth in this agreement. The driver must not go above the suggested pricing guidelines.
