### Criteria for Application for the Two Delegate-Elected Board Seats on the GMWA Board of Directors

1. To be considered for one of the two elected seats (voted on by the convention members) on the Board of Directors, a prospective candidate must have at least 10 years of continuous membership and service in his/her local chapter along with 10 years of regular and uninterrupted attendance at annual convention sessions of the Gospel Music Workshop of America, Inc. The local Chapter Representative can assist you in verifying this information. However, this needed information must be in writing and submitted to the Board of Directors through the Chair of the GMWA Nominating Committee.
2. Submit your **complete portfolio package by May 30, 2019** to Rev. Dr. Issac Whittmon, Chairman of the Nominating Committee. **The portfolio package must include:**
  - A. Three ( 3) Letters of Recommendation:
    - a) One from the Pastor of your Church.
    - b) One from your Local Chapter Representative.
    - c) One from an organization in which you have affiliation (i.e., social, religious, professional, civic, etc.)
  - B. A Chapter Representative seeking a seat MUST submit a **Letter of Character** from **Dr. Spencer White**, President of the Chapter Representatives Division.
  - C. A petition with at least ten (10) signatures from members of your local chapter who are, and **who** have been in good standing in the local Chapter for at least the past three(3) years.
  - D. Five (5) **current and professionally prepared Photographs - Photos will not be returned to you.**

3. Submit a **written** expository in 100 words or less which must include your reason(s) for desiring to become an Delegate-Elected member of the Board of Directors of the Gospel Music Workshop Board of Directors.
4. **You will be required to meet with the Board of Directors. Rev. Dr. Whittmon will arrange for this meeting and will also notify you of the time and date in which you are to appear.**
5. The submission of this application indicates your willingness to attend all schedule Board Meetings and Annual Conventions as well as adhere to all outlined financial responsibilities as assessed by the Board of Directors.
