The GMWA New Artist Showcase is designed for unsigned artists and general convention delegates at the 2019 Convention held in Washington, DC. The Showcase will convene, Tuesday July 30 – Thursday, August 1 at the Washington Hilton (DuPont Circle) in the Courtyard. Artists interested in participating who qualify as “unsigned artists by a major label” or “Independent Artist” must complete their online registration form via the GMWA website by Monday, July 22.

The registration fees are as follows:

Soloists: \$50

Groups with 10 or fewer members: \$80

Choirs with 11 or more members: \$125

Please note: All participants **MUST** have a badge to perform on stage. If you are not registered for the convention, you and each of your group members must obtain a *One Day Pass* prior to the performance. Each One Day Pass costs \$50 and can be purchased on-site at the registration area or online.

Sound Check is from 1:15 – 2:00pm and the showcase begins at **2pm**. Each New Artist will be allotted up to/no more than 10 minutes for their presentation. Persons performing by tracks must submit their track to the on-site production manager upon arrival at 1:15pm.

New Artists will perform in front of a stellar group of panelists that include executives from major record labels, radio personalities and gospel music industry leaders. Award winning gospel artists will serve as hosts. At the end of the showcase we will announce the “Panels Pick” for the artist that showcased the best presentation for an opportunity to perform at another event later in the convention.
